**FOURTH INTERIM ORDER REVIEW
DETERMINATION SUMMARY
25 MARCH 2025**

PRIVATE HEARING

Name of Registrant: Mohammed Ul-Haq

Registration number: 01-31900

Professional status: Optometrist

Type and length of interim order: The Fitness to Practise Committee determined to make an interim order of conditional registration from 19 May 2023 for a period of 18 months.

On 18 October 2023, 28 March 2024 and 6 September 2024, the Fitness to Practise Committee determined to maintain the current interim order of conditional registration. On 25 March 2025, the Committee varied the existing conditions.

The Committee notes that the substantive hearing in this matter is listed before the next six monthly review is due and therefore makes no order for a further review. However, if the substantive hearing is not completed then a further review will need to be listed within 6 months from today.

The list of public conditions imposed are as follows:

A1	Standard conditions
A1.1 Informing others	You must inform the following parties that your registration is subject to conditions. You should do this within two weeks of the date this order takes effect.

	<ul style="list-style-type: none"> a. Any organisation or person employing or contracting with you to provide paid or unpaid optical services, whether or not in the UK (to include any locum agency). b. Any prospective employer or contractor where you have applied to provide optical services, whether or not in the UK. c. Chairman of the Local Optometric Committee for the area where you provide optometric services. d. The NHS body in whose ophthalmic performer or contractor list you are included or are seeking inclusion.
<p>A1.2 Employment and work</p>	<p>You must inform the GOC if:</p> <ul style="list-style-type: none"> a. You accept any paid or unpaid employment or contract, whether or not in the UK, to provide optical services. b. You apply for any paid or unpaid employment or contract to provide optical services outside the UK. c. You cease working. <p>This information must include the contact details of your prospective employer/ contractor and (if the role includes providing NHS ophthalmic services) the relevant NHS body.</p>
<p>A1.3 Supervision of Conditions</p>	<p>You must:</p> <ul style="list-style-type: none"> a. Identify a remote supervisor who would be prepared to monitor your compliance with conditions A1.3 (d), (e), (f) and (g) of these conditions. b. Ask the GOC to approve your workplace or remote supervisor within 2 weeks of the date this order takes effect. If you are not employed, you must ask us to approve your workplace supervisor before you start work. c. Identify another supervisor if the GOC does not agree to your being monitored by the proposed supervisor.

	<ul style="list-style-type: none"> d. Place yourself under the supervision of a supervisor and remain under his/her supervision for the duration of these conditions. e. Arrange for your supervisor to review a minimum of ten randomly selected patient records once every month. f. To identify and agree with your supervisor any further CPD and/or learning in respect of record keeping, patient management and referrals. g. To seek guidance from your supervisor in respect of any concerns in being able to complete a full and accurate contemporaneous record and/or action referrals on the same day as the patient appointment. h. At least every three months or upon request of the GOC, request a written report from your supervisor, which should include the outcome of your supervisor's review of the random sample of patient records, including any referrals if made. In addition, the report should include a summary of CPD and/or learning carried out. i. Inform the GOC of any proposed change to your supervisor and again place yourself under the supervision of someone who has been agreed by the GOC.
<p>A1.4 Other Proceedings</p>	<p>You must send to the GOC by 4pm on the 15 April 2025 a record of CPD undertaken since 1 February 2024 to date together with relevant CPD certificates.</p>
<p>A1.5 Registration requirements</p>	<p>You must inform the GOC within 14 days if you become aware of any criminal investigation or formal disciplinary investigation against you.</p>
<p>A1.6</p>	<p>You must continue to comply with all legal and professional requirements of registration with the GOC.</p> <p>A review hearing will be arranged at the earliest opportunity if you fail to:-</p> <ul style="list-style-type: none"> a. Fulfil all CPD requirements; or b. Renew your registration annually.
